

As part of the American Recovery and Reinvestment Act of 2009, the U.S. Department of Energy is providing funding to states and territories to support consumer rebate programs for ENERGY STAR qualified appliances. Under these programs, consumers can receive rebates to purchase energy-efficient appliances when they replace used appliances. Eligibility guidelines, covered products, and rebate amounts differ by state, so consumers should review program requirements carefully.



## ARIZONA

### REBATES AVAILABLE - PROGRAM CLOSED; WAITLIST ONLY

Rebates for clothes washers, dishwashers, electric heat pump water heaters, gas storage water heaters, and gas tankless water heaters began on April 12, 2010 and ended on June 1, 2010. Rebates for refrigerators, freezers, room air conditioners, and solar water heaters with electric or gas backup began on July 1, 2010, and ended July 24, 2010. However, consumers can join a waitlist in the event additional funds become available. ### HOW TO APPLY

No reservations are required. Consumers should make a purchase and then apply for a rebate. Purchaser must supply a residential address where the appliance is installed. Prepaid cards will only be mailed to a P.O. Box if a physical street address is provided. Rebate forms must be completely and accurately filled out and accompanied by proof of purchase. Consumers must also self-certify that the new unit replaced an existing appliance. Arizona encourages residents to recycle the old appliances.

### ELIGIBILITY

Eligibility limited to Arizona residents. Rebates are only available for the replacement of existing units with new qualifying appliances. Products must be delivered to and installed in a residential property in Arizona. Purchase must be made at an Arizona retail location. Limit one rebate per product type per household. Rebates will be awarded on a first-come, first-served basis until the allocated program funds are depleted.

Purchase must be made during the rebate offer period. Only ENERGY STAR qualified refrigerators, freezers, room air conditioners, and solar water heaters at the stated rebate levels are eligible. Qualifying units must be listed on the ENERGY STAR Web site at [www.energystar.gov](http://www.energystar.gov). Business customers and business installations are not eligible for rebate(s).
