

As part of the American Recovery and Reinvestment Act of 2009, the U.S. Department of Energy is providing funding to states and territories to support consumer rebate programs for ENERGY STAR qualified appliances. Under these programs, consumers can receive rebates to purchase energy-efficient appliances when they replace used appliances. Eligibility guidelines, covered products, and rebate amounts differ by state, so consumers should review program requirements carefully.

REBATES AVAILABLE

Rebates for all products except heat pump water heaters began at 11 a.m. Eastern Time on April 28, 2010. Rebates for heat pump water heaters began on May 28, 2010. Rebates may be offered for a limited time only. The rebate program will end when funds run out. Before making a purchase, confirm funding and requirements with the [program sponsor](#) listed in the HOW TO APPLY section.

Furnaces (Gas)		ENERGY STAR qualified. Has an Annual Fuel Utilization Efficiency (AFUE) of at least 90%.	\$250

Split systems must have a heating seasonal performance factor of at least 8.2, a Seasonal Energy Efficiency Ratio (SEER) of at least 14.5, and an Energy Efficiency Ratio (EER) of at least 12. Single-package equipment must have a heating seasonal performance factor of at least 8, a SEER of at least 14, and an EER of at least 11.	\$300
Refrigerators		ENERGY STAR qualified.	\$60
WATER HEATERS	Electric Heat Pump	ENERGY STAR qualified.	\$250
	Gas Storage	ENERGY STAR qualified. Has an Energy Factor (EF) of at least 0.62.	\$35
	Gas Tankless	ENERGY STAR qualified. Has an Energy Factor (EF) of at least 0.82.	\$225

HOW TO APPLY

Applicant should check with their gas or water utility to determine if the utility is participating in the rebate program; participating utilities will provide further instructions regarding rebate reservations and forms. If the applicant's utility is not participating in the rebate program, then the applicant must reserve a rebate from the program sponsor, below. Applicants must certify that the purchased product replaces an existing appliance and that the replaced appliance was properly disposed of.

ELIGIBILITY

Consumer must be a Virginia resident. Purchased appliances must be for residential use only, and must replace an existing appliance. Appliances must be purchased from a Virginia retailer or vendor. Rebates limited to one per household.
